1 Introduction

This is a report on the survey and analysis methods used in a follow-up study of adult users of information, advice and guidance. The study aimed to assess the net added value of adult advice and guidance over that of information only in terms of learning, work and career outcomes. Both the initial study (wave one) and this follow-up study (wave two) were carried out on behalf of the Department for Education and Skills (DfES) by the Institute for Employment Studies supported by Ipsos MORI.

Findings from the research and further information about the survey background and methodology are published separately. Interim findings (from wave one) are published as 'Intermediate Impacts of Advice and Guidance' DfES Research Report 638. Overall findings (from both waves) are published as 'Assessing the Net Added Value of Adult Advice and Guidance', DfES Research Report 825A.

1.1 Overview of methodology

The overall research involved three phases: a development phase, the wave one survey and the wave two (follow-up) survey. During the development phase in 2003 the research team undertook a critical review of relevant literature to assess the main policy issues and to draw lessons from the research methodologies utilised in order to refine the proposed research approach. Also during the development phase the population of service users was defined (see below). The wave one survey in 2004 established a large and unbiased sample to both enable control and treatment groups to be established and to allow for tracking of outcomes over time. This first survey collected information through a 30 minute telephone interview on variables that could affect or influence learning, work and career outcomes and also measured the shortterm impact of information, advice and guidance on service users. The second or follow-up survey in 2006 collected further evidence on the observable and attitudinal or behavioural outcomes of information, advice and guidance for the group of surviving respondents. This second survey was also conducted via telephone interview but the interview was shorter at 25 minutes. The following sections of this technical report give more detailed descriptions of how individuals were sampled and surveyed, and how the data were analysed.

2 Research Design

2.1 Sample design - wave one

The first study (wave one) involved interviews with 4,361 adults. The survey population for the first wave consisted of adults in England who had received information (I), advice (A) or guidance (G) from a known source between autumn 2003 and spring 2004, and was restricted by age (all aged 20 or above) and qualification level (all qualified to NVQ level 2 or below).

The original sample was constructed to include all recipients of IAG and to allow for comparing the experiences and attitudes of those who received a more intensive type of intervention, ie Advice or Guidance (the 'treatment' group) with those who had only received Information (the 'control' group). This decision was taken in an attempt to control, as much as possible, for endogenous factors (such as levels of motivation to change, propensity to seek help), by concentrating the study on those seeking and receiving at least Information, rather than looking at the general population in totality (ie by not including those who were not seeking any help at all).

Three different sample sources were selected for the study: **learndirect**, JobCentre Plus and LSC (Learning and Skills Council)/IAG Partnerships (now known as nextstep). It was intended that **learndirect** would be the main provider of the Information or control sample; that the JobCentre Plus client base would provide sample for the treatment group, as all clients receive at least advice (A); and that LSC/IAG Partnerships would provide sample for both the control and treatment groups. The **learndirect** sample was drawn from one single source as was the JobCentre Plus sample, but as LSC/IAG Partnerships involved a wide variety of partnerships and providers, the sample was drawn from a random sample of 18 partnerships. These partnerships were: Berkshire IAG Partnership, Coventry and Warwick IAG Partnership, Derbyshire IAG Partnership, Essex IAG Partnership, Humberside IAG Partnership, Kent and Medway IAG Partnership, London South IAG Partnership, London West IAG Partnership, Milton Keynes IAG Partnership, Norfolk IAG Partnership, Nottinghamshire IAG Partnership, South Yorkshire IAG Partnership, Staffordshire IAG Partnership, Sussex IAG Partnership, The Black Country IAG Partnership, Tyne and Wear IAG Partnership, West of England IAG Partnership, and West Yorkshire IAG Partnership.

The selected Partnerships, **learndirect** and JobCentre Plus were then asked to provide details of all their clients who met the criteria (in terms of age, qualification level and contact date). A random sample of clients were drawn from the **learndirect** and JobCentre Plus samples, using a 'one-in-n' approach, along with the entire sample provided by the selected Partnerships and this provided a total sample of 20,281. Table 2.1 reports the total number of leads issued, the number of interviews achieved, the number of refusals and ineligible respondents, as well as the adjusted response rate for each sample source.

Note: In total, 2,476 leads were still being called at the end of the survey. Many of these leads had been called well over ten times, but without a final outcome. Because it is not possible to be definite over whether or not they would have been a valid sample (eg the named person may not live there anymore, or they may have been screened out at the beginning of the questionnaire), these numbers have been allocated as valid/invalid in the same proportion as the rest of the sample, ie 51 per cent: 49 per cent overall.

At wave one a total of 4,361 adults were interviewed including 2,980 from **learndirect**, 395 from JobCentre Plus and 986 from LSC/IAG Partnerships. This gives an overall valid response rate of 42.1 per cent.

Despite intentions, it was not possible prior to the survey to determine exactly what level of service an individual had received and therefore to assign them to either the control or treatment group. As a result the wave one survey had to determine the level of intervention received through a respondent self reported measure. This measure was tested thoroughly before use. Combining sample source and self reported measure of level of service accessed shows how the responding sample at wave one were assigned to the control and treatment groups (see Table 2.2).

2.2 Sample design - wave two

Of the 4,361 respondents to wave one, 3,335 of these (77 per cent) agreed to be recontacted for this follow-up survey essentially providing the starting sample. All these individuals were sent an advance letter to inform them that they would soon be contacted by an Ipsos MORI telephone interviewer, to explain the aims of the survey and to encourage participation (see section 5.3 for a copy of this contact letter).

Table 2.3 reports the total number of leads issued for wave two, the number of interviews achieved, the number of refusals and ineligible respondents, as well as the calculated adjusted response rate.

As the table shows, there was a relatively large proportion of numbers being out of service or incorrect ('bad numbers') as individuals had moved. This is likely to be explained by the length of time that elapsed between the first survey and the follow-up (wave one and wave two). A number of techniques were employed to try to reduce these bad numbers including:

 sending a newsletter to all respondents to wave one feeding back results from the first survey and asking for any changes in contact details (see section 5.2 for a copy of the newsletter)

- contacting individuals a number of times (at least 25 times) and at various times of the day/different days of the week, and
- trying to find alternative telephone numbers for respondents including using telephone look-ups to find landline numbers for those who had given mobile numbers only.

However it is important to note the number of refusals was relatively low, giving a response rate of 71 per cent for those that were contacted during the fieldwork period. In total, 1,273 IAG recipients were interviewed. This represents an overall adjusted response rate was 60 per cent.

Note: In total, 530 leads were still being called at the end of the survey. Nearly all of these leads (95 per cent) had been called well over 10 times, but without a final outcome. It is assumed that these numbers would have a similar profile to the overall sample, and so have been allocated as valid/invalid in the same proportion as the rest of the sample, ie 64:36 per cent overall

3 Fieldwork

3.1 Survey development and fieldwork - wave one

The wave one survey was conducted by telephone, by MORI Telephone Surveys (MTS) using Computer Aided Telephone Interviewing (CATI). Interviews took an average of 30 minutes each and took place between 28 July and 30 September 2004. The wave one survey collected detailed information on variables that could affect or influence outcomes, and focused on: work situation, work history, current and recent involvement in learning and training, current qualification level, attitudes to work and learning, satisfaction with work and learning achievements, work and learning plans for the future, and type of careers support received and the perceived positive effects of this (see section 5.1 for a copy of the wave one survey questionnaire).

3.2 Survey development and fieldwork - wave two

The questionnaire for this wave two survey was designed by the Institute for Employment Studies (IES), with input from Ipsos MORI. The questionnaire used many of the questions from the wave one survey, however some questions were deleted, new questions were added to address issues of policy relevance and revisions to existing questions were made. Importantly, the questionnaire length was reduced from 30 minutes to 25 minutes by removing unnecessary questions such as some of the detailed personal questions which were asked in the first survey (eg gender, ethnicity and age).

The questionnaire covered the following topics:

- current work situation and recent work history (since wave one, including changes in work situation)
- outcomes of learning reported at wave one, current and recent involvement with learning and training activities, and current qualification levels

- recent IAG services accessed (since wave one), nature of support received, motivation for seeking help, and satisfaction with IAG intervention. Plus use of the internet as a source for information, advice and self-assessment; and willingness to pay for IAG services
- general attitudes towards learning/training, and satisfaction with own work and learning/training achievements
- plans for the future in terms of career mobility and intention to pursue learning/ training opportunities
- perceived positive effects of IAG intervention
- personal details including source and level of income (see 5.4 for a copy of the wave two questionnaire).

The questionnaire was programmed into CATI format and several logic and consistency checks were included to minimise keying errors and implausible answers. As much of the questionnaire was repeated from wave one and therefore thoroughly tested a small pilot of 15 telephone interviews was conducted prior to the main stage fieldwork to test the new questions and check the questionnaire length and flow. A few minor amendments to the questionnaire were made as a result of the pilot, mainly to ensure the average questionnaire length did not exceed 25 minutes.

The interviewing was conducted by telephone, by Ipsos MORI Telephone Surveys (MTS), using Computer Assisted Telephone Interviewing (CATI). All interviewers were fully briefed prior to starting the fieldwork. The telephone interviews took place between 26 May and 30 June 2006.

4 Matching and Weighting

The primary objective of the research was to assess the effectiveness of IAG services on outcomes for individuals, essentially to establish a causal connection between the IAG intervention and an outcome; and then to track changes over time. A number of techniques were used to analyse the data in order to a) compare the outcomes of a control and a treatment group; and b) to explore changes over time from wave one to wave two of the study.

4.1 Comparing outcomes of a control and treatment group in an non experimental design

A control group of low-level service users was determined to demonstrate the counterfactual position – to demonstrate what would have happened to individuals if they had not accessed in-depth IAG services (essentially the absence of treatment of advice and/or guidance). The outcomes of the two groups could then be compared, and any differences in the outcomes would represent the added value of the additional services provided to the treatment group.

However, in using a control group, it is advisable to match them to the 'treatment' sample on observable characteristics, eg gender, age, activity status/history, educational attainment etc. This is important as the control group are likely to differ from the treatment group in a number of ways and these differences may explain differences in outcomes rather than the different treatments received. For example, even if there was no additional impact of in-depth IAG support, the treatment group might be expected to outperform the control group because they are, say, better educated with greater work experience, or simply have higher motivation levels to progress. Or conversely, even if the additional level of IAG were to have an impact, it might not raise the outcomes of the treatment group sufficiently to show an effect in comparison to the low-level service user (or control) group.

One way around the potential bias of a control group is to use propensity score matching (PSM; Rosenbaum and Ruben, 1983; 1985)¹. This technique has been used recently in the evaluation of the impact of the Education Maintenance Allowance (Ashworth et al., 2001; 2002)², the New Deal for the Long-term Unemployed (Lissenburg, 2001)³, and the New Deal for Lone Parents (Phillips et al., 2003)⁴. The essence of the technique is to find a person in the control group who is as similar as possible to one in the treatment group and to pair off these matched-individuals. This is done for all the individuals in the treatment group. The degree of similarity is measured by the propensity score. This propensity score is derived from a regression of the probability of a person being in the control group conditional upon the characteristics of that individual. If all the characteristics that influence the outcomes are included in the model, PSM provides matched groups that are equivalent to the random allocation of people to treatment and control groups.

The PSM technique, specifically kernel matching, was used at wave one to match the control and treatment groups as closely as possible and the results of the analysis presented in the first research report 'Intermediate Impacts of Advice and Guidance' (DfES Research Report 638) indicate that the process was successful (see also Table 4.1 below).

4.2 Comparing outcomes over time

There was significant attrition (loss of respondents from wave one to wave two) present in the wave two survey, therefore to allow comparability between waves non-response weights were generated that would also take into account the need to keep the control and treatment groups as well-matched as possible. These weights essentially weight the wave two dataset up to the same size as the wave one respondent population and this allows aggregate comparison of the control and treatment groups at wave one and at wave two, to measure changes over time for

both groups. The process involved a number of key steps and generated a complex weight variable.

To generate this set of complex weights, the pattern of non-response was firstly modelled as non-response was found to be non-random. The modelling process used logistic regression with separate models produced for the control group (I) and the treatment group (AG). In the model the dependent variable was taken to be whether, or not, the individual responded at wave two (1=yes, 0=no). The independent variables included in the model were the same variables as those used to generate the propensity score matching model described above¹ as well as including qualification level and learning history and are noted in Table 4.1. All independent variables used were key labour market and learning statistics gathered at the wave one survey, baseline figures and which would not have been altered by receiving either I or A/G.

The next step involved calculating the reciprocal of the predicted possibilities generated by the two logistic regression models to provide a weight variable with which to adjust the data. However, as there were some extreme values for these weights, such as values over 1,000, all non-response weights in the bottom ten per cent and top ten per cent of the distribution were scaled upwards or downwards respectively to decrease the spread of the weights. The next step was to multiple the trimmed non-response weight values by the PSM (propensity score matching) weight generated at wave one. Finally, an adjustment was made to ensure the distribution of the control group weight values and the treatment group weight values were consistent across waves one and two – a post-stratification adjustment.

A similar post-stratification technique has been used in a recent evaluation of the New Deal for Lone Parents. More information can be found in Technical Report for the New Deal for Lone Parents quantitative survey undertaken by M Phillips, K Pickering, S Purdon and J Hales in 2003.

The stages to creating the post-stratification weight were:

- 1. to divide the propensity scores of the weighted treatment (A/G) group at wave one into five groups of approximately the same size
- 2. to use the values (as shown in Table 4.2) which defined these five percentile groupings to define strata for the propensity scores of the wave two treatment and control groups (A/G and I groups respectively)
- 3. and then, estimate the weighted proportion of the population at wave two (using the interim weight as described by the process above) in each stratum for the I and AG groups separately. Finally, compare the wave two weighted proportions with their respective weighted proportions at wave one, and calculate the adjustment required to make them equal. Together these constituted the post-stratification weight.

Therefore the final complex weight used in the analysis to account for attrition was the combined non-response weight, wave one PSM weight and post-stratification weights (see Table 4.6 for outcomes of the weighting process on key sample characteristics).

4.3 Comparing outcomes captured at wave two only - rematching the surviving control and treatment groups

In order to analyse new data captured at wave two (that was not also captured at wave one) it was necessary to re-match the surviving control and treatment group members, using the kernel propensity score matching technique as described above. The same variables used in the PSM procedure at wave one were used to re-match at wave two (see Table 4.4). These variables were the personal, work and learning characteristics that were recorded at wave one, not those captured at wave two, as these baseline characteristics could not have been altered by the Information, Advice and Guidance support received.

Unless otherwise stated, all variables are coded as dummy variables (1 = yes, 0 = no). Given that there was some missing data on all variables, and that the PSM procedure will not include cases with any missing values on the predictor variables, the reference value for the majority of the categorical variables above (eg ethnicity, caring responsibilities etc.) is 'missing'.¹ The outcomes of the PSM process are shown in Table 4.5, and the effect on the sample characteristics are indicated in Table 4.6.





What is Information, Advice and Guidance?

Using careers and learning support services (i.e. services that offer information, advice and guidance to people about jobs and learning opportunities) is one way that adults thinking about getting involved in or continuing with learning can find out about what is available and what will suit them. These services are also useful for people thinking about changing what they do at work, or wanting to plan their career in the short, medium and longer term.

These services are on offer from a range of places including:

- dedicated careers services through nextsteps offices across the country
- telephone helplines such as learndirect
- jobcentres nationwide for those trying to get back into work
- colleges and education providers

informally at work and through family and friends.

Why conduct a survey?

As people can get careers and learning support from so many places, it can be difficult to understand what people actually get out of these services. In order to make sure that the government (through the Department of Education and Skills) is supporting the right types of services, it is important that they look carefully from time to time at what works best for users.

By talking to you, and others like you, this survey is trying to understand whether offering people support with their career and/or learning decisions actually makes a difference to the choices they make and what they do as a result. To really understand this, we need to keep in touch with you over time to see what changes you make to your life in relation to your work and learning situation.

What do people think?

In total we interviewed about 4,400 people who had used some form of Information, Advice or Guidance service. This gives us a very good idea of what people think of these services and what changes they have made to their work and learning situations.

Over a relatively short period of time, the survey shows that people have made some significant changes to their lives. The survey also provides some information on what people thought about the services they received. Overall, people appear to be very happy with these services. However, there are always ways in which things can be improved.

The charts on the next page show these findings in more detail.






